NOTICE PURSUANT TO ARTICLES 13-14 OF GDPR (GENERAL DATA PROTECTION REGULATION) 2016/679

In accordance with the regulations specified, this processing will be based on the principles of fairness, lawfulness, transparency, and the protection of your privacy and rights.

In accordance with Article 13 of GDPR 2016/679, we provide you with the following information:

1. PURPOSE OF PROCESSING

The personal data (name, surname, email address, and phone number) provided by filling out the form will be used for the following purposes:

- 2. NATURE OF DATA PROVISION AND CONSEQUENCES OF REFUSAL TO RESPOND

5. DURATION OF PROCESSING
